Trunkline Gas Company, LLC ("Trunkline") submits herewith for filing with the Federal Energy Regulatory Commission ("Commission") the following revised tariff record to its FERC NGA Gas Tariff, Fourth Revised Volume No. 1, proposed to become effective August 1, 2025.

#### STATEMENT OF THE NATURE REASONS AND BASIS

On February 3, 2025, Trunkline submitted its compliance filing in Docket No. RP25-487-000 ("February 3rd Compliance Filing") in accordance with the Commission's Final Rule for Order No. 587-AA1 which incorporated by reference the latest version of the business practice standards adopted by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB"), Version 4.0, and the standard revised by Minor Correction MC24002. Trunkline herewith submits a correction to the "GT&C Section 25. - Business Practices Standards" tariff record submitted in its February 3rd Compliance Filing to include verbiage specifically related to Minor Correction MC24002 ("Correction Filing").

Attached hereto as Appendix A, Trunkline presents a redlined comparison between the versions of the tariff record submitted in its February 3<sup>rd</sup> Compliance Filing (tariff record version 7.0.0) and this Correction Filing (tariff record version 7.0.1) which reflects the addition of the Minor Correction MC24002 language as related to NAESB WGQ Standard 3.4.1.

## **IMPLEMENTATION AND WAIVER REQUESTS**

Pursuant to Section 154.7(a)(9) of the Commission's Regulations, Trunkline requests that the proposed tariff record be accepted effective August 1, 2025, the implementation date of the NAESB Version 4.0 standards in accordance with Order No. 587-AA, and the same effective date which was requested in Trunkline's February 3rd Compliance Filing. Additionally, as a result of this Correction Filing, Trunkline requests that the tariff record submitted in its February 3rd Compliance Filing be rejected as moot.
