Dear Ms. Bose:

On February 2, 2017, the Federal Energy Regulatory Commission ("FERC" or "Commission") issued an Order Issuing Certificate ("Order")¹ for the Rover Pipeline, Panhandle Backhaul, and Trunkline Backhaul Projects.

In compliance with Ordering Paragraph (F)(2) of the Commission's Order, and Section 157.20(d)(2) of the Commission's regulations, Rover Pipeline LLC ("Rover") notifies the Commission that on August 31, 2017, Rover placed in-service the following facilities:

Rover Phase 1A Facilities

- Cadiz Lateral, Mainline A, Supply Connector Line A
- Cadiz A Receipt Meter Station
- Cadiz B Receipt Meter Station
- ANR Delivery Meter Station
- PEPL Delivery Meter Station

In addition, Panhandle Eastern Pipe Line Company, LP ("Panhandle" or "PEPL") and Trunkline Gas Company, LLC ("Trunkline") notify the Commission that on August 31, 2017, the following facilities were placed in-service:

- Edgerton Compressor Station
- Zionsville Compressor Station
- Montezuma Compressor Station
- Tuscola Compressor Station
- Edgerton 10 Gate Valve Setting
- Zionsville 3 Gate Valve Setting
- Tuscola 6 Gate/ Mainline Scrubber
- Panhandle-Rover Interconnect

Rover will provide separate notification following the placement into service of any remaining facilities for which Rover has received Commission authorization to place into service.

Furthermore, Rover notifies the Commission that it placed in-service its FERC NGA Gas Tariff, Original Volume No. 1, on August 31, 2017.²
